Sub : Extension of the tenure of Managing Committee(s)/ Ad hoc Committee(s)/ Administrator(s) of non- Govt. Junior High, High and Senior Madrasah(s) (Aided & un-aided) recognized by West Bengal Board of Madrasah Education

The students of the Madrasahs were unable to attend the Institute during the long COVID-19 period. Still now, we are not completely free from COVID-19 pandemic. It is a pleasure to us that the Government of west Bengal has now allowed the students of Class IX, Class X, Class XI and Class XII to attend the Madrasah though, the students of other classes are not allowed to come to the Madrasah till date.

Considering the above mentioned situation and in continuation of the previous Memo No. 536/MC/2021 Dated : 17.06.2021 of this Board, the President, West Bengal Board of Madrasah Education, in exercise of the power conferred upon him under sub- section (2) of section 21 of West Bengal Board of Madrasah Education Act 1994, has been pleased to grant extension of the tenure of the Managing Committee(s) / Ad hoc Committee(s)/ Administrator(s) of non- Govt. Recognized Madrasah up to 30.06.2022 for the madrasahs, where reconstitution will be due within or up to 30.04.2022.

Where the term of the Managing Committee(s) / Ad hoc Committee(s)/ Administrator(s) is valid up to 31.12.2021 and election in guardian category has been completed within 31.12.2021, the term of the Managing Committee(s) / Ad hoc Committee(s)/ Administrator(s) is extended up to 31.03.2022 or till the completion of the election of office bearers whichever is earlier.

Where the term of the Managing Committee(s) / Ad hoc Committee(s)/ Administrator(s) is valid up to 31.12.2021 but the election in guardian category is not held within the period, the term of the Managing Committee(s) / Ad hoc Committee(s)/ Administrator(s) is extended up to 30.06.2022 . It is imperative that the election in guardian category of those madrasahs will be completed within this period.

The Board however, reserves the right to appoint Administrator/Ad-hoc Committee or to extend the tenure of the Managing Committee where the same would be necessary for administrative reason.

This Circular is not applicable to the Madrasah(s) where any contrary order from the Hon'ble Court prevails or any court case related to Management of recognized Non-Government Madrasahs(aided and unaided) Rules-2002 remains pending.

This Circular is not also applicable to the Madrasah(s) where illegal appointment of Teachers and Non-teaching staff has/have been made by the Managing Committee(s)/ Ad hoc Committee(s)/Administrator(s) of the said Madrasah(s).

In case of any doubt or dispute, the same shall be referred to West Bengal Board of Madrasah Education whose decision thereon, shall be final.
