Sub : **Postponement of Election for Constitution /Reconstitution of the Managing Committee/Ad-hoc committee/Organizing Committee/Administrator of recognized Madrasahs up to the date of issuance of the due Constitution Notification constituting the new House(s) concerned is issued by the Commission, in view of ensuing Parliamentary Election 2024 declared by Election Commission, Govt.of India**

In exercise of the powers conferred by Sub – section (2) of Section 21 of West Bengal Board of Madrasah Education Act 1994 ,the President is pleased to notify for general information that in view of the Election in Parliamentary Constituencies, declared by the competent authority through notification and enforcement of Model Code of Conduct with effect from 16.03.2024 to till the due Constitution Notification constituting the new House (s) concerned is issued by the Commission, the process of Constitution/ Reconstitution of the Managing Committee in Madrasahs shall remain suspended w.e.f 16.03.2024 till the date of issuance of the due Constitution Notification constituting the new House(s) concerned is issued by the Commission.

1. In cases of Madrasahs where the process of Election for different stages have already been started but not completed till 16.03.2024 , the remaining part shall be started after the due Constitution Notification constituting the new House (s) concerned is issued by the Commission adopting programmes afresh as per normal rules and procedure.
2. In cases of Madrasah where Elections of different categories other than office Bearers have already been completed prior to 16.03.2024, the election of Office Bearers shall stand deferred upto the date of issuance of the due Constitution Notification constituting the new House (s) concerned is issued by the Commission.
3. In case of Madrasahs where election is due but have not yet adopted any programme for Election will take steps for the Constitution /Reconstitution of the Managing Committee as per Rule after the date of issuance of the due Constitution Notification constituting the new House (s) concerned is issued by the Commission.
4. The tenure of the Managing Committee/ Ad-hoc Committee/ Organizing Committee/ Administrator of the Madrasahs of West Bengal is extended from 16.03.2024 to 31.08.2024.
5. In case the tenure of the Managing Committee/ Ad-hoc Committee/ Organizing Committee/ Administrator of the Madrasah has already been expired before 16.03.2024, those Madrasahs should apply separately to the office of the West Bengal Board of Madrasah Education.
6. The Board however reserves the right to appoint Administrator /Ad-hoc committee where the same would be necessary for administrative reasons
7. The above Notification is not applicable to Madrasahs where any contrary order from the Hon'ble Court prevails.
