## Sub: Re-opening of Madrasahs after Summer Vacation

Pursuant to the order of the Minority Affairs & Madrasah Education Department, Government of West Bengal, vide No. 2366-MD/O/2M-06/2019 –MAME dated 27/05/2024 and in continuation of the Notification issued by the West Bengal Board of Madrasah Education vide Memo No. 589/Aca/24 dated 18/04/2024, I am directed to inform all concerned that the competent authority has approved the following schedule for re-opening of Government/ aided/ un-aided Madrasahs:

- (1) The teaching and non teaching staff of all recognized Madrasahs (Government Model Madrasahs (English Medium), Non-Government Aided Madrasahs and Un-aided Madrasahs) within the State of West Bengal be advised to attend Madrasahs from 03 June, 2024, subject to the directions issued by the concerned Election Authorities as the case may be, due to ensuing Parliament General Elections-2024, to ensure the suitable Madrasah infrastructure is in place, with the appropriate assistance of the District Magistrate/ Commissioner Kolkata Municipal Corporation, as the case may be, before the Madrasahs are opened for students.
  - It is expected that the above arrangement will be completed by 09.06.2024.
- (2) The stated recognized Madrasahs (Government Model Madrasahs (English Medium), Non-Government Aided Madrasahs and Un-aided Madrasahs) may be opened for students from 10.06.2024 onwards.

The teaching and non teaching staff of all recognized Madrasahs shall made suitable arrangements appropriate to the Madrasahs, in the interest of the students, for conducting extra classes to make up the losses of classes due to preponement of Summer Vacation.

All Heads of the Madrasahs are requested to comply with the above mentioned order accordingly. This is issued with the approval of the President of West Bengal Board of Madrasah Education
