Farukuddin Ahamed, Assistant Teacher Bengali (H/PG): The petitioner is claiming that he has been recruited as Assistant Teacher Bengali (H/PG) on 04.11.2015 on the strength of the Resolution dated 04.11.2015 vide Memo No. 13/15 adopted by the Managing Committee. The petitioner could not produce any Appointment Letter, Joining Report or Work Done Certificate, some photocopies of such documents have been produced. Secondly, the petitioner obtained 40% marks in his B.A. Examination and the petitioner had no B.Ed degree on the date of his alleged recruitment. It is apparent that the petitioner had no requisite qualification to be appointed as Assistant Teacher Bengali (H/PG). The Resolution Book also does not reveal that the Rules of Recruitment as per Govt. Notification No. 93-SE/S/10R-14/2013 dated 09.02.2015 were complied with at the time of recruitment of the petitioner. There is no signature of the petitioner in the official Attendance Register. The Headmaster also did not see the petitioner to work in any capacity in the Madrasah. The D.I. of Schools, 24 Parganas also corroborated such statement of Headmaster.

Under the circumstances stated above, we are of confident view that the petitioner was never recruited following the Rules of Recruitment being Govt. Notification No. 93-SE/S/10R-14/2013 dated 09.02.2015 and never worked in the Madrasah.

## **OBSERVATION**

Sarifa Khanam, Assistant Teacher Math (Pass): The petitioner did not appear for verification of her educational testimonials, Appointment Letter, joining letter and did not even produce any Work Done Certificate. The Headmaster has stated that the petitioner is the daughter of the then Secretary of the Managing Committee, Md. Wahadul Islam. Headmaster further stated that the petitioner was never recruited following the Rules of Recruitment being Notification No. 93-SE/S/10R-14/2013 dated 09.02.2015 and the petitioner had no requisite qualification to be appointed as Assistant Teacher Math (Pass). We also do not find any Resolution in the official Resolution Book or the signature of the petitioner in the official Attendance Register so as to ascertain that she was recruited following the Rules of Recruitment. D.I of Schools, North 24 parganas also corroborated that she was never recruited following the Rules of Recruitment.

Under the circumstances stated above, we are of considered view that the petitioner was never recruited following the Rules of Recruitment being Govt. Notification No. 93-SE/S/10R-14/2013 dated 09.02.2015 and never worked in the Madrasah.

Nargis Parvin, Assistant Teacher History (Pass): The petitioner is claiming that she was recruited in terms of Resolution No. 313/15 dated 04.11.2015 and she has been working since 04.11.2015. The petitioner could not produce any Appointment Letter, joining report or any Work Done Certificate. In absence of any such document, it is next to impossible to hold that the petitioner was recruited following the Rules of Recruitment. She had no B.Ed degree on the date of her joining and she obtained 33.5 % marks in B.A.

The petitioner had no requisite qualification on the date of her alleged appointment.
