Sk. Nobinewas, the Petitioner is claiming that he was appointed as Asstt. Teacher Arabic (pass) in terms of the order dated 25.08.2015 passed by Hon'ble Division Bench of Calcutta High Court in AST No. 192/2014, AST No. 140/2014 and MAT No. 473/2014. No such direction was ever passed by the Hon'ble High Corut for appointment of the Petitioner. As per the report of D.I. of Schools, the Chuadanga Jr. High Madrasah was not recognized by the Government in the year 2016 and the Madrasah had not recognized and valid Managing Committee in the year 2016. The Teacher In-charge of Chuadanga Jr. High Madrasah also did not appear despite repeated issuance of notices.

Under such circumstances the claim of the Petitioner appears to be fake and fabricated.

One Mr. Atiar Rahman, Asstt. Teacher of Kaderia High Madrasah lodged complaint stating interalia that all the present teachers of Chuadanga Jr. High Madrasah are illegally drawing salary since they were allegedly recruited when the Madrasah was not recognized by West Bengal Board of Madrasah and there was no valid Managing Committee. For that reason, the Teacher In-charge, Mamoni Sasmal @ Faria Tabasum did not appear before this Committee with the Resolution Book was not placed containing Application No.177 of 2022 before the committee constituted by Hon'ble Supreme Court. They are drawing salary illegally causing huge loss to the public exchequer. We, therefore, drawn the attention of the Government to look into the matter.

Under the circumstances stated above, we are of considered opinion that the Petitioner was never appointed following the Rules of Recruitment being No. 93-SE/S/10R-14/2013 dated 09.02.2015 and the Petitioner never worked in Chuadanga Jr. High Madrasah.
