Teacher-in-charge of the Madrasah stated that the Petitioner was appointed as temporary employee in the Madrasah on 27.04.2016. There is no resolution to show that following the Rules of Recruitment the Petitioner was recruited by the Madrasah. In absence of any signature of the Petitioner on the official Attendance Register, we cannot hold that he has been since 24.02.2016. The Work Done Certificate issued by working Secretary/President cannot be accepted in view of the statement of the Teacher-incharge that the Petitioner was appointed as temporary employee of the Madrasah.
