




OBSERVATION

Md. Sariful Islam, Group-C (Clerk): The Petitioner is claiming himself as Group-C (Clerk) of Imdadul Ulum Sr. Madrasah (Fazil) and he has been working since 24.02.2016. As per the statement of the Petitioner, he was directly given appointment by the Secretary without following the Rules of Recruitment. Teacher-in-charge of the Madrasah stated that the Petitioner was appointed as temporary employee in the Madrasah on 27.04.2016. There is no resolution to show that following the Rules of Recruitment the Petitioner was recruited by the Madrasah. In absence of any signature of the Petitioner on the official Attendance Register, we cannot hold that he has been working since 24.02.2016. The Work Done Certificate issued by the Secretary/President cannot be accepted in view of the statement of the Teacher-in-charge that the Petitioner was appointed as temporary employee of the Madrasah.






OBSERVATION

Md. Safiul Alam, Group-D: The Petitioner is claiming himself as Night Guard of Imdadul Ulum Sr. Madrasah (Fazil) and he has been working since 23.02.2016. The Teacher-in-charge has stated that the Petitioner was appointed on temporary basis as Night Guard and there was no resolution that the Petitioner was recruited following the Rules of Recruitment procedure. The D.I. of Schools, Malda also corroborated such statement of Teacher-in-charge.

Having regard to the facts and circumstances of the case and in absence of any material resolution about compliance of recruitment rules, we do hold that the Petitioner was never appointed following the Rules of Recruitment being Govt. Notification No. 93-SE/S/10R-14/2013 dated 09.02.2015 and the Petitioner never worked in the Madrasah.




