




OBSERVATION

Sahinur Rahaman Sardar, Assistant Teacher, Bengali (H/PG)): As per Managing Committee Meeting No. 12 dated 29.08.2019, the petitioner was appointed directly as Assistant Teacher of Bengali and accordingly the petitioner joined the Madrasah on 11.09.2019. On careful scrutiny of the original Resolution Book produced by the Superintendent, Rakibul Islam, we do not find any such Resolution dated 29.08.2019. That clearly goes to say that the petitioner has based his claim on some imaginary Resolution of the Managing Committee. There is no signature of the petitioner in the official attendance register produced by the Superintendent of the Madrasah and A.D.I, Basirhat have categorically stated that the petitioner was never recruited following the Rules of Recruitment as per Govt. Notification No. 486-MD/0/2M-11/2016 dated 03.03.2016

Under the circumstances stated above, we are of considered opinion that the petitioner was never recruited following the Rules of Recruitment as per Govt. Notification No. 486-MD/0/2M-11/2016 dated 03.03.2016 and he never attended the Madrasah (having no signature in the Official attendance register).

OBSERVATION

Abdul Kaiyum Mondal, Assistant Teacher Arabic (H/PG)): The petitioner having no requisite qualification to be appointed as Assistant Teacher in Arabic and claimed himself as Assistant Teacher (Arabic) of the Madrasah appointed as per Managing Committee Meeting No. 12 dated 29.08.2019 and joined the said Madrasah on 11.09.2019.

The Work Done Certificate has been granted for the period from 11.09.2019 till 30.09.2019 and no Work Done Certificate has been granted by Md. Rakibul Islam, Superintendent of Madrasah. We do not find any Resolution vide Managing Committee Meeting No. 12 dated 29.08.2019 in the original Resolution Book and also we do not find the signature of the petitioner in the official Attendance Register.

In the premises set-forth above, we are of the considered opinion that the petitioner having no requisite qualification was never recruited following the Rules of Recruitment as per Govt. Notification No. 486-MD/0/2M-11/2016 dated 03.03.2016 and he never attended the Madrasah. The Work Done Certificate appears to have been manufactured and for only 20 days have been granted by some unauthorized person.




OBSERVATION


Ummey Habiba, Assistant Teacher Bengali (Pass): The petitioner having no requisite qualification to be appointed as Assistant Teacher in Bengali and claimed herself as Assistant Teacher (Bengali) of the Madrasah appointed as per Managing Committee Meeting No. 12 dated 29.08.2019 and joined the said Madrasah on 11.09.2019.

The Work Done Certificate has been granted for the period from 11.09.2019 till 30.09.2019 and no Work Done Certificate has been granted by Md. Rakibul Islam, Superintendent of Madrasah. We do not find any Resolution vide Managing Committee Meeting No. 12 dated 29.08.2019 in the original Resolution Book and also we do not find the signature of the petitioner in the official Attendance Register.

In the premises set-forth above, we are of the considered opinion that the petitioner having no requisite qualification was never recruited following the Rules of Recruitment as per Govt. Notification No. 486-MD/0/2M-11/2016 dated 03.03.2016 and she never attended the Madrasah. The Work Done Certificate appears to have been manufactured and have been granted by some unauthorized person only before 20 days.

OBSERVATION

Sazia Karim, Assistant Teacher Geography (H/PG)): The petitioner did not turn up despite issuance of several notices. On the strength of Managing Committee Meeting No. 12 dated 29.08.2019, the petitioner is claiming herself that she has been appointed as Assistant Teacher (Geography) in Katia S.R. Ali Sr. Madrasah. On scrutiny of the original Resolution Book, we do not find any such Resolution dated 29.08.2019. Md. Rakibul Islam, Superintendent of Madrasah and Santa Das, A.D.I, Basirhat has specifically stated that the petitioner was never recruited following the Rules of Recruitment as per Govt. Notification No. 486-MD/0/2M-11/2016 dated 03.03.2016.

Under the circumstances stated above, we have no hesitation to say that Sazia Karim was never recruited following the Rules of Recruitment as per Govt. Notification No. 486-MD/0/2M-11/2016 dated 03.03.2016 and she never worked in the Madrasah (having no signature in the official Attendance Register).




OBSERVATION

Md. Jahangir Sardar, Group-C (Clerk) : On the basis of Managing Committee Meeting No. 12 dated 29.08.2019 and Work Done Certificate issued by the Secretary and Asstt. Superintendent In-charge for the period from 11.09.2019 to 30.09.2019, the petitioner is claiming that he was appointed as Group-C (clerk) employee and he has been working in the Madrasah since then. The original Resolution Book produced by the Superintendent, Md. Rakiful Islam does not reveal in such meeting No.12 dated 29.08.2019 of the Managing Committee.

Secondly, the Superintendent, Md. Rakibul Islam being In-charge of the Madrasah did not grant any Work Done Certificate. We also do not find the signature of the petitioner in the official Attendance Register maintained by the Madrasah.

Under the circumstances stated above, we have no hesitation to say that the petitioner was never recruited following the Rules of Recruitment as per Govt. Notification No. 486-MD/0/2M-11/2016 dated 03.03.2016.






Ebrahim Gain, Group-D : On the basis of Managing Committee Meeting No. 12 dated 29.08.2019 and Work Done Certificate issued by the Secretary and Asstt.
