




OBSERVATION

Ajoy Rakshit, Asstt. Teacher, Bengali (H/PG):- As per the appointment letter, the petitioner was appointed in terms of Special Meeting No. SPL/01/KHM/HS/2018 dated 10/03/2018 of the Managing Committee and he has been working in the Madrasah since 16/03/2018.

Except the letter of appointment, joining letter and the Work Done Certificate issued by the President of the Madrasah, the petitioner could not produce any Attendance Register or Resolution to show that he was validly recruited as Assistant Teacher of the Madrasah.

On careful consideration of the original Resolution Book, produced by the Headmaster of Khaskhamar High Madrasah, Howrah, we do not find any Resolution as has been mentioned in the appointment letter of the petitioner. There is no signature of the petitioner in the official Attendance Register maintained by the Madrasah. The Headmaster of Khaskhamar High Madrasah, has specifically stated that he never saw the petitioner to attend the Madrasah in any capacity and there is absolutely no Resolution in respect of the appointment of the petitioner. The ADI of Schools, Uluberia, also corroborated such statement of the Headmaster.

Under such circumstances stated above, we are of the considered view that the petitioner, Ajoy Rakshit was never recruited following the Rules of Recruitment as per Government Notification No. 486-MD O 2M-11 2016 dated 03/03/2016 and he never worked in the Madrasah as Assistant Teacher.





Faruk Gazi, Assistant Teacher, Bio Science (Pass):- As per the Photostat copy of the appointment letter, the petitioner, Faruk Gazi was appointed on the strength of Special Meeting no. SPL-01/HS/2016 dated 11/01/2016.

The Headmaster of the Khaskhamar High Madrasah, Nazrul Islam Mallick, never saw the petitioner to attend the Madrasah in any capacity and there is no Resolution adopted by the Managing Committee for initiation of recruitment of the petitioner. There is no such Resolution in the official Resolution Book as has been mentioned in the appointment letter of the petitioner. There is no signature of the petitioner in the official Attendance Register of the Madrasah. On the basis of an imaginary Resolution, the petitioner is claiming himself to be an employee of the Madrasah. The Headmaster and the ADI, Basirhat have unequivocally stated that the Rules of Recruitment as per Govt. Notification No. 93-SE/S/10R-14/2013 dated 09/02/2015 were never complied with in the alleged appointment of the petitioner and the petitioner never worked in the Madrasah.

Under such circumstances stated above, we are of the considered view that the petitioner, Faruk Gazi was never recruited following the Rules of Recruitment as per Government Notification No. 93-Se/S/10R-14/2013 dated 09/02/2015 and he never worked in the Madrasah as Assistant Teacher.
