Smt. Papi Das Roy, The Petitioner is claiming herself as legally recruited Asstt. Teacher, Bengali (H/PG) in Mathabhanga High Madrasah, Coochbehar. As per the Petitioner she joined the said Madrasah on 25.02.2016. Admittedly, the Petitioner never appeared in any written examination. The Petitioner also did not sign in the official Attendance Register and her service was never approved by D.I. of Schools, Coochbehar.

The Headmaster, Md. Abdul Baten Ali has produced one Resolution Book containing two resolutions of 2015 and 2016. The remaining pages of that Resolution Book are blank. The Headmaster admitted that original Resolution Book containing the entire matters of management have not been produced by him. It is apparent from the statement of the Headmaster that the Rules of Recruitment as per G.O. No. 93-SE/S/10R-14/2013 dated 09.02.2015 were not followed at the time of alleged recruitment of the Petitioner.

The D.I. of Schools, Samar Chandra Mondal has categorically stated that the claim of the Petitioner is fake and fabricated for the reasons that the external experts as mentioned in the alleged Resolution Book of the Managing Committee, have specifically stated that their signatures were forged in the Resolution Book of the Managing Committee.

Admittedly, the Rules of Recruitment has stated in G.O. No. 93-SE/S/10R-14/2013 dated 09.02.2015 were not complied at the time of recruitment of the aforesaid petitioner. The Resolution Book appears to have been manufactured for the purpose of this verification process. Admittedly, the Petitioner never signed the official Attendance Register. The signatures of experts have been forged as per the statement of D.I. of Schools. All such documents have also been filed by D.I. of Schools.

In the premises set-forth above, we are of the considered opinion that petitioner, Smt. Papi Das Roy never recruited following Rules of Recruitment being No. 93-SE/S/10R-14/2013 dated 09.02,2015 and she never worked in Mathabhanga High Madrasah. Documents in support of her appointment have been manufactured as per the statement of D.I. of Schools.

In that view of this matter, the Work Done Certificate issued by the Headmaster could not be

relied upon.

Emran Miyan, The Petitioner is claiming himself that he was appointed as Group-D (Peon) at Mathabhanga High Madrasah on 24.02.2016. He did not appear in any written examination. He never signed on the official Attendance Register. The Headmaster has also admitted that the Rules of Recruitment being No. 93-SE/S/10R-14/2013 dated 09.02.2015 were not complied with at the time of alleged appointment of Emran Miyan.

D.I. of Schools, Coochbehar has also stated that the papers have been manufactured and the Petitioner was never appointed following the Rules of Recruitment. The Headmaster intentionally suppressed the official Attendance Register and did not produce the official and original Resolution Book of the Managing Committee of Mathabhanga High Madrasah. Only one Resolution Book containing two resolutions of 2015 and 2016 has been produced. The remaining pages of such Resolution Book are blank.

Having regard to the circumstances and the documents filed by D.I. of Schools, we are of the considered opinion that the petitioner, Emran Miyan was never recruited following the Rules of Recruitment being No. 93-SE/S/10R-14/2013 dated 09.02.2015 and the certificate issued by the Headmaster cannot be relied on. The Resolution Book, certificate and other documents have been manufactured to get undue advantage in matters of verification process.

Indrajit Paul, The Petitioner is claiming himself as Asstt. Teacher, Math (H/PG) of Mathabhanga High Madrasah and that he was appointed on 22.02.2016. Admittedly, Indrajit Paul obtained his B.Ed degree as regular student in the year 2017 and therefore he had no requisite qualification to be appointed as Asstt. Teacher Math (H/PG)in Mathabhanga High Madrasah on 26.02.2016.

Indrajit Paul never appeared in any written examination for being recruited as Asstt. Teacher Math. He also did not sign on the official Attendance Register since his alleged joining in Mathabhanga High Madrasah. Headmaster has also admitted that the Rules of Recruitment being No. 93-SE/S/10R-14/2013 dated 09.02.2015 were not complied with at the time of alleged recruitment of Indrajit Paul.

The Resolution Book containing only two resolutions for the year 2015 and 2016 is not the original Resolution Book of the Managing Committee but the same has been manufactured for the purpose of this verification process.

The Headmaster intentionally suppressed the original Resolution Book and the Attendance Register in order to keep the Committee dark about the actual state of affairs. The D.I. of Schools has also stated that the Petitioner was never appointed following the Rules of Recruitment and the documents have been manufactured by the alleged members of the Selection Committee of Mathabhanga High Madrasah, Coochbehar to give legality in the alleged appointment of the Petitioner.

In the premises set forth above, we are of the considered opinion that petitioner, Indrajit Paul has no requisite qualification following the Rules of Recruitment being No. 93-SE/S/10R-14/2013 dated 09.02.2015 and he never worked in Mathabhanga High Madrasah.

MoksadulAlam, The Petitioner is claiming himself to be a Group-C employee of Mathabhanga High Madrasah. As per the statement of the Petitioner he joined the said Madrasah on 25.02.2016. The Headmaster himself stated that Rules of Recruitment were not followed at the time of recruitment of Moksadul Alam. But Moksadul Alam has stated that he duly appeared in the written examination and before the Interview Board for being recruited as Group-C employee.

The Resolution Book containing only two Resolution Books for the year 2015 and 2016 appeared to have been manufactured. As per D.I. of Schools, documents were manufactured by the Petitioner and they were never appointed following the Rules of Recruitment. The original Resolution Book and the Attendance Register have not been produced by the Headmaster in order to keep the Committee in dark about the actual state of affairs.

Moreover, the Petitioner being brother of the then Secretary of the Managing Committee has taken undue advantage to be part of the conspiracy in manufacturing documents.

In the premises set-forth above, we are of the considered opinion that petitioner, Moksadul Alam has no requisite qualification following the Rules of Recruitment being No. 93-SE/S/10R-14/2013 dated 09.02.2015 and he never worked in Mathabhanga High Madrasah.
