Tanmoy Pal, Assistant Teacher, History (Pass): The petitioner, Tanmoy Pal is claiming himself that he was appointed as Assistant Teacher, History (Pass) of the Rambag Siddiquia Jr. High Madrasah, Purba Medinipur on 03/12/2019 and he has been working in that Madrasah since 16/12/2019. The petitioner obtained 47% marks in his B.A. examination and B. ED. degree in the year 2014.

Admittedly, the petitioner obtained less than 50% in aggregate and thereby, ineligible to be appointed as Assistant Teacher. In other words, the petitioner had no requisite qualification to be appointed as Assistant Teacher of the Madrasah.

Secondly, the Managing Committee of the Rambag Siddiquia Jr. High Madrasah, Purba Medinipur was recognized as new setup Jr. High Madrasah on27/10/2010 vide Memo. No. 4378 for one year, subject to fulfilling of the condition mentioned in such letter of recognition.

The document filed by the Headmaster reveals that finally, the Board extended the term of Ad-hoc Managing Committee of Rambag Siddiquia Jr. High Madrasah, for one year with effect from 18/05/2019 vide Memo. No. 774/1(2)/MC/19 dated 02/07/2019.

Admittedly, the Ad-hoc Managing Committee of the Madrasah cannot recruit teachers out of its own but, the teachers of the new setup of the Madrasah should be appointed by the Managing Committee only on the recommendation of the West Bengal Madrasah Service Commission for selection of teachers in the Madrasah. Therefore, on 03/12/2019, 16/12/2019, there was no valid sanction of the Madrasah and the Ad-hoc Managing Committee had no lawful authority to appoint/recruit any full time teacher in the Madrasah. The Work Done Certificate, advertisement made in the Newspapers etc. have become redundant for want of recognition of the Madrasah and its Managing Committee. The attested copy of the Attendance Register also become redundant, since the Ad-hoc Managing Committee had no authority to recruit teachers. The Resolution of the Ad-hoc Managing Committee could not be verified for want of the original Resolution Book. The advertisement in the Newspapers sent to the Government for approval etc. also become redundant for not having valid sanctioned Madrasah and its Managing Committee. The D.I./ADI of Schools, Purba Menidipur, Mr. Subhasis Mitra, by filing a specific report, has stated that the Madrasah Committee was not recognized by the Board and that alleged appointment of teachers was never made following the Rules of Recruitment as per Govt. Notification No. 486-MD/O/2M-11/2016 dated 03/03/2016. As per the report of the DI of School, the petitioner was never recruited with the permission of the ADI, Contai or DI of School, Purba Medinipur.

The statement of the Headmaster, Mr. Md. Mahboob Hossain, cannot be accepted without perusing the original Resolution of the Madrasah and the original Attendance Register. There was no vacancy existed on 03/12/2019 as Assistant Teacher, History (Pass) in the Madrasah.

Under the circumstances stated above, we are of the definite opinion that the petitioner, Tanmoy Pal was never recruited following the Rules of Recruitment as per Govt. Notification No. 486-MD/O/2M-11/2016 dated 03/03/2016and he never worked in the Madrasah as legally recruited Assistant Teacher in the Madrasah. The document filed by the petitioner, can safely be ignored, having regard to the fact that the petitioner had no requisite qualification to be appointed as Assistant Teacher of the Madrasah and the Ad-hoc Managing Committee had no legal right to recruit any teacher for the Madrasah.

Barun Maity, Assistant Teacher, Pure Science (Pass):-As per the statement of the petitioner, Barun Maity, he was recruited on the basis of the decision of the Ad-hoc Managing Committee of the Madrasah vide Meeting No.01/19/SLP dated 13/11/2019 as Assistant Teacher. In absence of the original Resolution Book of the Ad-hoc Managing Committee, we cannot accept the said Resolution of the Ad-hoc Managing Committee.

Secondly, the Managing Committee of the Rambag Siddiquia Jr. High Madrasah, Purba Medinipur was recognized as new setup Jr. High Madrasah on 27/10/2010 vide Memo. No. 4378 for one year, subject to fulfilling of the condition mentioned in such letter of recognition.

The document filed by the Headmaster reveals that finally, the Board extended the term of Ad-hoc Managing Committee of Rambag Siddiquia Jr. High Madrasah, for one year with effect from 18/05/2019 vide Memo. No. 774/1(2)/MC/19 dated 02/07/2019.

Admittedly, the Ad-hoc Managing Committee of the Madrasah cannot recruit teachers out of its own but, the teachers of the new setup of the Madrasah should be appointed by the Managing Committee only on the recommendation of the West Bengal Madrasah Service Commission for selection of teachers in the Madrasah. Therefore, on 03/12/2019, 16/12/2019, there was no valid sanction of the Madrasah and the Ad-hoc Managing Committee had no lawful authority to appoint/recruit any full time teacher in the Madrasah. The work done certificate, advertisement made in the Newspaper etc. have become redundant, for want of recognition of the Madrasah and its Managing Committee. The attested copy of the attendance register also become redundant, since the Ad-hoc Managing Committee had no authority to recruit teachers. The Resolution of the Ad-hoc Managing Committee could not be verified for want of the original Resolution Book. The advertisement in the Newspaper, papers sent to the Government for approval etc. also become redundant for not having valid sanctioned Madrasah and its Managing Committee. The D.I./ADI of Schools, Purba Menidipur, Mr. Subhasis Mitra, by filing a specific report, has stated that the Madrasah Committee was not recognized by the West Bengal Board of Madrasah Education and that alleged appointment of teachers was never made following the Rules of Recruitment as per Govt. Notification No. 486-MD/O/2M-11/2016 dated 03/03/2016. As per the report of the DI of School, the petitioner was never recruited with the permission of the ADI, Contai or DI of School, Purba Medinipur.

The statement of the Headmaster, Mr. Md. Mahboob Hossain, cannot be accepted without perusing the original Resolution of the Madrasah and the original attendance register. There was no vacancy existed on 03/12/2019 as Assistant Teacher, Pure Science (Pass) in the Madrasah.

That clearly goes to show that the petitioner had no requisite qualification to be appointed as Assistant Teacher English (Pass).

The appointment letter reveals that appointment was given by Ad-hoc Managing Committee of Rambag Siddiqua Jr. High Madrasah.

Admittedly, Ad-hoc Managing Committee of Madrasah cannot recruit Teachers but the Teachers are to be recruited through the West Bengal Madrasah Service Commission. Even if there is no existence of such Madrasah Service Commission, the Ad-hoc Managing Committee of a Madrasah cannot recruit any Teacher. Therefore, the recruitment of the petitioner by the Ad-hoc Managing Committee is contrary to the Rules and Regulation as well as the direction given by West Bengal Board of Madrasah Education.

In the premises set-forth above, the document filed by the petitioner showing recruitment process or attendance of the petitioner in the Madrasah, cannot be considered in view of the fact that there was no legality in the alleged recruitment of the petitioner. The A.D.I, Contai as well as D.I, Purba Medinipur also by filing a specific report stated that the Rules of Recruitment were not followed by the Madrasah since the Madrasah was not recognized on the date of alleged appointment.

In such circumstances, we have no hesitation to say that the petitioner having no requisite qualification, was never recruited following the Rules of Recruitment as per Govt. Notification No. 486-MD/0/2M-11/2016 dated 03.03.2016 and the petitioner did not work in the Madrasah as a legally recruited Teacher. The statement of the acting Teacher-in-charge of the Madrasah cannot be accepted for want of original Resolution Book and for the simple reason that the Ad-hoc Managing Committee was extended by the West Bengal Board of Madrasah Education vide Memo No. 774/1(2)/MC/19 dated 02.07.2019.

Lijamuddin, Secretary directly handed over the appointment letter to him and thereby he was recruited as Peon. Admittedly, on 23.05.2018, there was no sanction of the Madrasah by the West Bengal Board of Madrasah Education and there was Ad-hoc Managing Committee of the Madrasah. Ad-hoc Managing Committee of the Madrasah has had no legal authority to recruit any Teaching-non-Teaching staff. The Headmaster also produced necessary documents to show that the Ad-hoc Managing Committee was extended till the middle part of 2020. Non-production of the original Resolution Book also does not inspire the confidence of the Committee Constituted by the Hon'ble Supreme Court to hold that such Resolution was actually passed by validly constituted Managing Committee of such Madrasah. Notification No. 486-MD/O/2M-11/2016 dated 03.03.2016 were not complied with at the time of recruitment of the petitioner since the Madrasah and it's Managing Committee were not recognized by the Board. In that view of this matter, the documents produced by the petitioner as well as Work Done Certificate ought to be ignored if not rejected under the premises set forth above.

We are of considered view that the petitioner was never recruited following the Rules of Recruitment as per Govt. Notification No. 486-MD/O/2M-11/2016 dated 03.03.2016 and he never worked in that Madrasah as legally recruited Group-D employee.
